Pursuant to the request contained in the motion of
Ronald S. Koppelman, Esq., dated February 26, 1976, attached
is a copy of the criminal record of John Tarpey, the alleged
president of EAGLE VENDING CORP.

The Miscellaneous Tax Bureau is seeking to revoke the
petitioner's license as a Wholesale Dealer of Cigarettes on
the ground that it is not a fit and proper party to be licensed
under Section 480 of the Tax Law. The character and reputation
of corporate stockholders, directors, officers and employees
are decisive elements in the appraisal of the fitness of a
corporation since a corporation can only act through individuals
and exists for the benefit of individuals.

WHEREFORE; it is respectfully requested that the request
for dismissal of the formal hearing be denied.

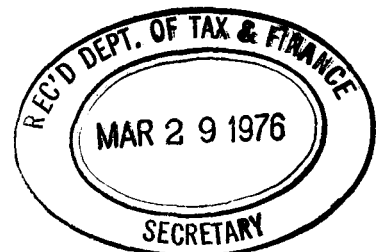
