
. Petitioner(s) ~~xxxxxxxxxxxx~~ did not appear at the scheduled hearing. A default has been duly noted.

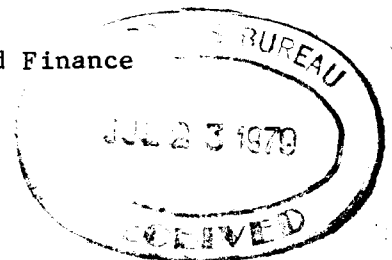

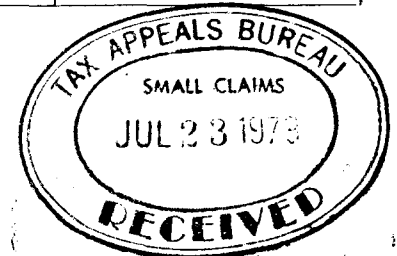
