ORDERED that the petition of Alex & Gloria Goun be and the same is hereby denied.

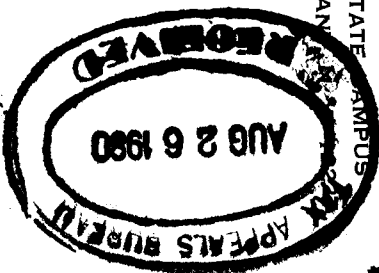
