My contention is that conditions have not changed and that my 1975 Income Tax Return as filed is proper and correct.

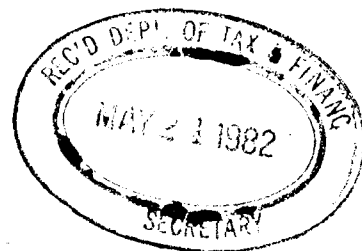
Based on the above I respectfully request that the default be vacated and assure you that I will file a perfected petition upon request.
