ORDERED that the petition of Stuart R. & Anita P. Breidbart, be and the same is hereby denied.

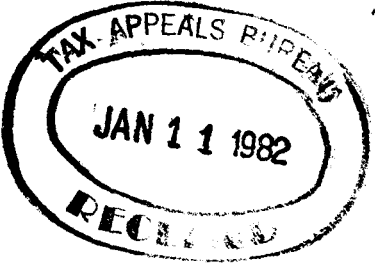

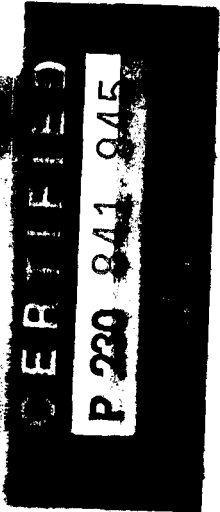


