This claim has been approved by Sales Tax Bureau personnel in accordance with Memorandum No. E-93 dated July 2, 1973.

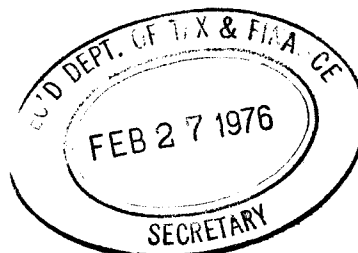
