Amount of Refund - \$46,857.34

The attached sales tax refund is being forwarded for your approval.

The basis for the refund is as follows:

Refund claim in the amount of \$49,404.84 has been reduced by \$2547.50 due to the Statute of Limitations. Refund in the amount of \$46,857.34, is granted of sales tax paid on electricity used in production. Refund is made with interest pursuant to Section 1139 of the Tax Law. This determination denying your claim in part will become final and irrevocable unless you apply to the State Tax Commission for a hearing within 90 days of the date of the refund check.

This claim has been approved by Audit Division personnel in accordance with Memorandum No. E-93 dated August 5, 1980.

Since the amount of this refund is more than \$25,000, it must be approved by more than one member of the State Tax Commission
